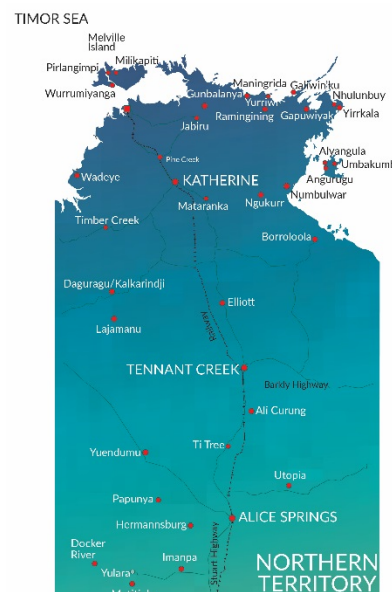
1 About Pirlangimpi

Pirlangimpi is located north of Darwin on the north-west coast of Melville Island and part of the Tiwi Aboriginal Land Trust.

Pirlangimpi was established by the Catholic Church as a Mission in 1940 and named Garden Point. In 1979, Garden Point was renamed to Pularumpi and later Pirlangimpi at the request from the traditional owners.

1.1 Population

In the 2016 Census, there were 371 people in Pirlangimpi (State Suburbs) Aboriginal and/or Torres Strait Islander people made up 91.3% of the population. The median age of people in Pirlangimpi (State Suburbs) was 34 years.



1.2 Power and water

Electricity is supplied by diesel generators. Chlorinated water is supplied to the town from a local spring situated approximately 1.8km from the town boundary. Two sewage ponds where wastewater is treated are also located on the town boundary.

A freight barge travels from Darwin biweekly.

1.5 Local government

Pirlangimpi Local Authority consists of 12 members and is the main forum for community management and local service provision issues. The Tiwi Island Regional Council oversees the local authority.

Pirlangimpi is located within the Tiwi Aboriginal Land Trust and is Aboriginal Land under the NT Land Rights Act (NT) 1976.
